# Quantico Shooting Club Annual Membership Meeting January 12th 2019

Location: WTBn Classroom

Chair: Vice President - Spencer Doll

Attendance: 58 members, roster available by request to operations officer.

#### Call to Order: 0802

Vice president addresses the membership and reads agenda.

- President, Mark Drinkwater Excused due to medical absence.
- Letter from operations officer read into record by club secretary. (see Attachment
   1)
- Vice president, Spencer Doll Delivered written remarks touching on successes and adversities faced by the club. (see Attachment 2)
- Member at large, Skip Booth Member at large states his function this year has been to ask the hard questions; "can we afford it" and "does it make sense" – and that's what he's done.
- Treasurer, Evan Palm "State of our finances is very good."
  - o Total of bank accounts "a little over \$47,000" vice the end of '17 when the club only had \$35,000.
  - o Gross membership dues increased by \$20,000 to ~ \$60,000 this year.
  - o We have lowered our expenses but we still need to lower them more.
  - o Currently we have a Net Revenue of ~ \$2,800.
  - Biggest expenses are payroll and EMT. EMT Expenses have been cut from \$15,000 in 2018 to \$11,000 in 2019. Kudos to Dave Sisson for his help on finding EMT coverage.
  - Treasurer's Statement of Activity & Financial Position were provided to membership. (Attachment 3)
- Club coordinator, Steve Mullins Detailed his position in coordinating with range control & Weapons Training Battalion (WTBn). "We have three major problems that you all don't care about or don't know about" (administrative note, Mr. Mullins did not elaborate as to what these three items were.) He asked the board what system was currently being used to schedule EMT's, which was answered by the chairman. Mr. Mullins reminded the membership that "we must live in the guidelines" set forth by the Marine Corps.
- WTBn Commander, Colonel Howard Hall Col. Hall addressed the membership on behalf of his position as the Commander of WTBn. He spoke on the importance of synergy between the club and the WTBn. The commander stressed the importance of safe, professional promotion of marksmanship and camaraderie.

- Col. Hall introduced Major Mark O'Drsicoll Officer in Charge of MCBQ Shooting Teams and welcomed him aboard the base as well as the QSC. Col Hall foot-stomped the white letter published by the Commandant of the Marine Corps driving off-duty pursuit of marksmanship by all Marines and hammered home that that is what the QSC exists to do.
- Audit Committee Head, Alexander Olbrich Reported that all audits are complete except 4<sup>th</sup> quarter of '18 and that everything looks good. He and all members of the current committee intend to continue into '19 however they do desire at least one additional member. Any member desiring to assist should contact the Operations officer to volunteer. A question was asked from the membership about help with Profits and Loss Statements (P&L). The member was directed to email the secretary or any board member expressing an interest to volunteer to help.
- Secretary, David Dix Apologized for late meeting minute posts for last meeting. Expressed to membership the volume of emails this board has communicated on. The secretary expressed gratitude for Dave Sisson help solve the EMT coverage issues. He was instrumental in finding coverage and helping to solve the scheduling dilemma. He also spoke on deficiencies in RSO program, Specifically, RSO appointment letters and the need to be able to show weapons familiarization for each RSO on the line for each weapon on the line, to range control. The secretary outlined binders that will be used to track documents for each RSO. In July, Doug Hurst sent an email to the board expressing a wish to retire. The secretary worked with Doug to try to find a way to staff the QShooting.com website. Due to the complexity of the site the board was unable to bring forward and staff Doug's site. The board will take one more look at continuing QShooting.com and then decide the best course of action. Moving forward, we must build a system that can be handled by our very diverse membership. Mark appointed the secretary to be the club's chief range safety officer in order for QSC to into compliance with MCBQO 5760.3B. Additionally, he briefed the contents of the newly designed RSO binders. He contacted MCB Performance and Innovation (P&I) office on the Bylaws and received a response that P&I does not need to sign off on Bylaws, however MCBO 5760.3B states they must. The secretary will be seeking official responses clearing up what does and does not need to be addressed in Bylaws. Many more contradictions exist with current correspondence between P&I and QSC Secretary on how to handle Bylaws. Pointed to MCBQO 5760.3B in that we must submit Bylaws prior to membership approval. Secretary will call for a special meeting to address bylaws in February; date to be determined. Reported on QSC meeting with base P&I on club recertification on Jan 15<sup>th.</sup> Secretary will keep membership up-to-date on this as they unfold. MaL asked a question on RSO scheduling program and when it can be up and running; answer is almost instantly, however, we would like it to run side-by-side. We would like to import gshooting to QSC website; discussion was had on how best to proceed.

A motion was made to extend meeting by one hour, the motion was seconded and a voice vote carried in favor.

 A motion made to accept the last meeting minutes, motion was seconded and a voice vote carried in favor.

**Old Business:** There was no old business on file, however; Steve Mullins questioned whether a nominating committee was stood up per discussions at last membership meeting. Discussion was had and it was made clear that an impartial election committee was stood up in agreement with the memberships wishes. This committee was present at meeting and would hold elections when turned over to them. A motion was made to close this subject and move one, seconded, and a unanimous yes vote carried.

#### **New Business:**

- Dave Sisson brought up his submission of a number of bylaw changes. The secretary and Mr. Sisson discussed tabling all Bylaw discussions until a special Bylaw meeting could be held. Much gratitude was expressed for Mr Sisson willingness to table this discussion and carry on with elections.
- Afshin Pashai spoke on the use of Gmail accounts being used when sending emails from club email causing emails to be alerted on as spam. The secretary informed the member that Gmail has not been used for that activity in months and that this is a closed issue. A solid email foundation is still being looked at.
- The secretary called a rule of order tabling discussions on technology use and requested that in the interest of time the member outline their topics for discussion and submit them to the board via email.

A motion was made to extend meeting by one hour, the motion was seconded and a voice vote carried in favor.

#### **Elections:**

The Board recognized the Election Committee had the floor. The Committee executed a call for nominees. No members opted to run for a board position. As such, all incumbents will remain in office. By uncontested default election the 2019 Quantico Shooting Club Board of Directors shall be:

#### **Address to Members:**

My name is Spencer Doll.

Six months ago, I attended the membership meeting and sat front row. I felt I had a lot to bring to the table and had many ideas to help this club grow; So much so that I brought 12 pages of notes on programs and fresh ideas. When it came time for new business, I raised my hand and to put it bluntly, I felt my voice was not heard.

The universe works in mysterious ways, and Today I am speaking to you as the acting Vice President. I was nominated to the position by the departing VP who stepped down in August, shortly after that same meeting where I felt ignored. Since then I have channeled the ideas from that notebook, and more importantly I've solicited input from members of this club. Here's what I've been up to.

#### Outreach.

A large part of outreach is social media. Like it or not, social media is pivotal in today's world, and this club needs to capitalize on that. We took a look at our current platforms and ID'd over 3,000 inappropriate posts on club branded social media including many that could have gotten our non-profit status revoked. I coordinated a team to remove anything political, sexual, or otherwise unprofessional and not in the best interest of the club. Once we had a professional face, we were able to engage with official outlets such as Quantico's official page and have seen traffic on social media grow by over 900%.

The component of the outreach plan I am most proud of has been to bring QSC to gun shows, a massive resource we had never touched before. The board invested less than \$2,000 in materials to have a professional image at shows and that was immediately met with our best weekend for memberships ever, garnering over \$8,000 in income in a single two day period. Shows are staffed by volunteers, as it's our members who make this club a success. We've been present at 4 so far and look forward to continue this into 2019.

At the start of my tenure this club had 799 members, and after our outreach drive we have 1,003, the most this club has ever grown in a year. 766 Regular and 237 Associate members. An increase of 14% and 32% respectively and 25% overall. Additionally, this is the first time in the history of the club we've had over 1,000 active members. The Treasurer will elaborate on the impact of this jump but the summary is the successes of this board allows the club the operating capital to better serve our membership.

I look forward to additional recruiting in 2019 to grow those numbers however outreach is more than recruiting. Talking to new people means nothing if we do not take care of our current members.

After hours digging through our system, I found a flaw in our mailing system. Simply put, many members weren't receiving messages, and Once rectified we saw twice the amount of people opening the emails as before. The email system still isn't perfect but we're leaps and bounds ahead of where we were, and I look forward to continuing the progress.

We also furthered caring for our current members by driving our internally held shooting sports to new heights. By equipping Match Directors with the tools and funds needed, 2018 saw a healthy match schedule and the return of Multi Gun events to the club. Disciplines such as 22 PRS, Vintage Sniper, Steel Challenge, and USPSA flourished with a board who has a respect for the effort it took our Match Directors to host these events. Matches resume in March and any member interested in being a part of it will have an opportunity to tie in where they desire this team is always seeking new members.

2018 was also witness to some great rec fire events, such as the "Red White and Blue" shootout which I organized, we drew a record 60+ members out to SAT for a catered meal and all the steel you could shoot.

In keeping with the spirit of giving back, we executed Toys for Tots and Eastern Armed Forces charity matches which donating thousands of dollars to charity.

The magic of our club is the expertise each and every one of our members brings to the table. I know what it feels like to have a good idea burning to make an impact and no one to hear it out.

The result of one of these good ideas was the first ever "Intro to USPSA clinic", free to our members. The club exists to promote marksmanship in all forms and this was the first taste of a clinic series that I am helping some motivated members bring to the club.. The club aims to put on courses rivaling what are offered at other ranges for hundreds of dollars at little to no cost to membership.

I have personally worked with several of our more technically inclined members to bring the club a revamped RSO, Medic, and Range scheduling database which will go online this month due to our current scheduling guru stepping down. Several other "techie" members are hard at work compiling a refreshed, modernized website we are hoping to roll out as soon as it's completed. All with the goal of better serving the club.

This morning I touched on just a few of the projects the board has been hard at work on. Looking ahead to '19 there is a pot of positive growth in store. The board serves at the request of the members and every action we've taken has been to open shooting opportunities to membership. I have been humbled to have served as the Interim Vice President.

Your choice to be here this morning is a statement that you desire to make a difference in the future of the club. If I am elected to serve as the VP I look forward to hearing your ideas and

seeing how far we can go together.
