# Old Business – A Year of Improvements

> A sample of the major accomplishments for 2021 – Theme was "See a Need, Fix the Need"

- Increased membership 31% through active social and web forum recruiting
- > Increased financial reserves by approximately \$42,000 through match revenue, new members and volunteer admin
- > Increased RSO pool and initiated QSC RSO Testing, as well as a weapon's familiarization course
- Increased ranges opened for members
- > Increased matches across almost all categories, which brought in new members and increased revenue
- Received a new 9-year authority to operate agreement with all Range Fees waived
- > Received additional storage Conex's and moved them to a central location on the property
- Updated website content and redesigned all member application forms
- Fixed the International Bunker Pavilion's roof and returned the Bunker Controller for repair
- > Fixed the water line issue at the clubhouse and had a new line and two taps installed
- Fixed the website's back-end CIVICRM database
- Fixed and performed maintenance on the Kubota
- Installed new windows and LED lights in the clubhouse
- > Installed a mini-split HVAC and upgraded the electrical capacity in the clubhouse
- Installed a wireless pull system for the skeet fields
- Removed dead trees from the property and ground dozens of stumps on the property
- Replaced and upgraded all IT systems
- > Painted the shotgun retaining fences for longevity and leveled the shotgun trailer for stability
- Bought a new Zero-Turn mower for the grounds
- Bought sufficient power and hand tools for match and daily operations

  - Facilities highly suggested self-help

UPDATE – House may be condemned and torn down unless we commit substantial funds to rebuild – Repair estimate up to \$9,500 – will initiate repairs fall 2021

Must pays (club required operations) equal \$66,481 or 563 Paid Memberships Annually. This is up from the \$46,000+ / 399 reported in Oct 2021 due to having to again pay an administrator in 2022.
